### What is the CAFADA project?

CAFADA is the Children and Families Affected by Domestic Abuse Project.



Our project is trying to find out how \*\*\*\* helps children when there has been hurting and fighting in a family.

We won't be asking you about the hurting that happened in your family.

We hope that you enjoy taking part in our research. But we know it can be difficult to think about some of these things.

The \*\*\*\* Coordinators will check in with you after you complete the workbook to make sure you are OK.

We do not plan to ask you any upsetting questions. But if you do get upset, please let the \*\*\*\* Coordinators know so that they can help.

Everyone who takes part will receive a £10 gift token. This is to thank you for your time and for sharing your views.

We hope our project will help us make sure services like \*\*\*\* help families as best they can.

### Do I have to take part?

No. You do not have to take part, it's entirely up to you. Your decision won't affect your relationship with \*\*\*\*.



If you change your mind once you have completed the workbook let us know. If you tell us up to 2 weeks after you have completed it, we can remove your workbook from our work.

### What will happen to my workbook once I fill it in?

Your workbook will be carefully and privately stored at the University of Stirling.

We will make sure the information from your workbook is anonymised. This means no one will be able to tell that you completed it. We will not tell anyone what you have written in your workbook.

We will keep your information securely at the University of Stirling for at least 10 years.

### What will you do with what you learn?



We will use information that you and others taking part tell us, to write reports for \*\*\*\*.

We will also make a version of the report that is shorter and easier to read and make this available to everyone who has taken part (and those who support them).

We will also write and share short reports (called 'articles') and talk to other researchers or professionals about what we have learned from you. We won't ever use your name in our reports or presentations or use any information that would identify you.

### How will information about me be used?

As part of the project, we will keep a small amount of personal information about the people who take part. For example, your age and gender.

This information will be processed in accordance with the General Data Protection Regulation (GDPR).

Under GDPR the legal basis for processing your personal data will be public interest/the official authority of the University.

You can ask to see a copy of any information we hold about you and to request corrections or deletions of information that is no longer required.
